Book Price Increase

The General Service Office of Alcoholics Anonymous posted the following announcement in the April-May 2005 issue of *Box 459*:

“On July 1, 2005 the price of all books, with the exception of the Big Book, *Alcoholics Anonymous*, will increase by \$1.00. This increase applies to books of all languages and formats, including hardcover, softcover, large-print, and booklets. The various formats of the Big Book will remain as currently priced.

The A.A. World Services Board also approved the implementation of a service charge on orders. The service charge will be 10% on all orders, with a minimum charge of \$3.00. Orders of \$250 or more will be exempt from the service charge.

Both of these measures, along with a broad cost-cutting plan at the General Service Office will go a long way in helping the trustees maintain a Prudent Reserve.”

Your Central Office Steering Committee is currently studying the impact of these price increases on the operation of Acadiana Central Office and is preparing a plan to present to the Central Office Representatives at the May 15, 2005 COR meeting.

Treasurer's Report: Bill S reported on behalf of Bob R. There was a starting balance of 2,000.00, a regular total income of 2063.55, and a sales income of 1347.15, for a total income of 3410.70. The regular expenses were 1886.89, sales expenses were 1375.70, for a total of expenses of 3262.59 for the month of February. The net income total was 148.11. We then transferred 148.11 back to the prudent reserve, leaving 2,000.00 for the regular working balance. The report was accepted.

COMMITTEE REPORTS

Activities: Todd D reported that they had set out over 200 chairs for the Chili cook-off, and all were full. The figures indicated a \$409.20 surplus after expenses were reimbursed. Thanks to Terry R for the use of his PA for only a \$25.00 donation. 150 fliers were given out for the Hawaiian BBQ, our next function.

Debbie C. from Step by Step will be the speaker at the BBQ. Volunteers will be needed, please see Todd D. Todd D thought that perhaps we could do a raffle where we keep all the \$. Last year we made a profit of only \$23 dollars, the year prior we were in the hole. This year the raffle took in 230.00 at the chili cook-off. 720.00 was taken in at the Christmas party and 150.00 at the BBQ. There was some discussion for and against the type of raffle previously mentioned. Ken mentioned that the bi-laws do state that money for the Central Office is to come from 3 sources.

So, events are 1 of 3 ways to bring in money. If the COR's believe the prudent reserve is in good shape, then the profit made at these events doesn't really matter. If the bi-laws are to be changed then we would need a 2/3 majority vote. Ken was not making a recommendation to do so, he was just providing the forum with information. Kathy asked if the bi-laws state a suggested amount for the prudent reserve. Ken answered with a no. Bill S said that we refer to as our prudent reserve is not really a prudent reserve. It's more like a cash account. We will use it as we need it and run it down if it comes to that. 8 years ago there was not a prudent reserve. Kathy asked what was Todd's actual concern. Todd thought that it was a means of producing more income for our Central Office. Mark suggested that we have a 50/50 raffle and a regular item raffle. Ken said that if you take a look back at the minutes from around 12-18 months ago; we were discussing the same topic regarding the raffles. The vote was approximately 13:1 to continue with a 50/50 raffle. Rod thought we should do both, and Jay agreed. The conclusion was that we would have both a 50/50 and an item raffle.

Lloyd reminded us that we need to have the menu for the BBQ finalized soon. It will cost money to rent a large pit. Lloyd will return with costs at the next meeting.

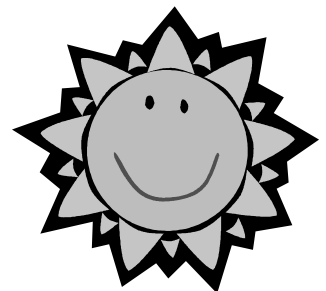
